



POLICY

OLYMPIC SPORT PARK



The operator of the Olympic Sports Park, address: H-9025 Győr, Radnóti Miklós út 46. (hereinafter referred to as Sports Park) is: Győr Projekt Kft. (Registered seat: H-9025 Győr, Radnóti Miklós út 46.)

The purpose of this Policy is to lay down the basic rules of behaviour for the users of the facilities, services of the Sports Park to ensure the high quality of its services. This Policy lays down the requirements (not specified elsewhere) visitors must comply with when they use the Sports Park, to ensure its normal use, good condition and safe operation.

GENERAL RULES

Opening hours of the Olympic Sports Park:

Monday to Friday: 06:00–22:00,
Saturday, Sunday: 07:00–21:00,
Holidays: closed.

Opening hours of tennis courts, for leisure sporting:

Monday to Friday: 06:00–22:00.
The latest hour courts can be booked for is 20:00!
Saturdays and Sundays: 07:00–21:00.
The latest hour courts can be booked for is 19:00!
Holidays: closed.
Closed during events.

Opening hours of the warm up track for leisure sporting:

Monday to Saturday: 19:00–21:00,
Holidays: closed.
Closed during events.

Depending on the type of events at the Olympic Sports Park, current opening hours may differ from the originally announced hours!

To use the Sports Park, the number of visitors must correspond to its purpose and occupancy permit. No user of the Sports Park may violate the relevant legislative requirements, provisions and the rules laid down in this Policy.

In the Sports Park, it is FORBIDDEN:

- to smoke and use naked flame, except at designated areas,
- to consume alcohol within the areas designated for sports,
- to do anything that is outside the scope of the services of the Sports Park, is against the law or violates public morals,
- to perform any activity that disturbs others with its noise, smell or any environmental damage,
- to use or abuse drugs, forbidden doping agents, narcotics, take in any dangerous materials and/or objects (explosives, pyrotechnics, weapons) any drinks or animals (except working/assistance animals),
- to do commercial, advertising, propaganda activities (i.e. to place advertising boards, folding pavement sign boards, wall stickers and leaflets), make audio records or photographs, provide forbidden gambling services or music.

Only parties who are in a legal relationship with the Operator may offer sports activities, courses trainings, organise & execute competitions, matches and/or perform any commercial or promotional activities in the entire area of the Sports Park.

The sports services offered by the Sports Park are available only during opening hours of the facility (except if a deviation from the opening hours is approved by the Operator in advance and is not against the law).

Persons under 18 years of age may use the services of the Sport Park only if they have a permission / association membership and under the supervision of their coach/trainer.

Minors who are between 6 and 14 years of age and members of different associations and/or take part on organised programmes may use the services offered by the Sports Park if they are accompanied by an adult/have the relevant permission.

Guests using the services of the Sports Park must, with regard to closing times, leave the facility in time, except if there is a separate agreement regulating their leaving otherwise.

In case of an irregularity (infringement of this Policy or the generally accepted norms of behaviour) the person who is behaving irregularly will be warned; if this does not have any results, then the Operator shall have the right to call the guest to leave and/or to exclude him or her from the users temporarily or permanently. In cases that reach beyond its right of action, the Operator shall have the right to ask help from the Police or other authorities, whose instructions must be followed by every person affected by the case. The quest who has been instructed to leave the facility may not raise any claims against the Operator.

The person who first notices any extraordinary event in the area of the Sports Park shall inform the Operator without delay via telephone. Depending on the nature of the extraordinary event, the followings must be notified via telephone:

Ambulance: 104
Firefighters: 105
Police: 107
EU emergency line: 112

The first aid location designated within the area of the building should be used to give first aid for persons suffering accidents in the facility.

- Front hall – reception desk at the main entrance
- Front hall – reception desk of the tennis court
- Gym building – reception desk

If there is a fire, everybody must leave the building, following the evacuation drawing displayed at his or here current location.

BASIC RULES FOR USE, BEHAVIOUR AND LIABILITY

The Sports Park may be entered during the times specified in the general rules.

All guests in the area of the Sports Park are obliged to maintain the orderliness and cleanliness, respecting other quests and civilised behaviour are a must.

The Operator may not be held liable for any damage to persons or material values if such occur as a result of non-compliance with the law or this Policy, or the irresponsible behaviour of the

guests or the abnormal use of equipment. In addition, the Operator may not be held liable for belongings, equipment lost or stolen. Please refer to the Operator's staff regarding the rules on using the equipment.

All guests must hand over found objects to the Operator and a protocol must be made on this.

All guests may use the services and sports equipment at their own responsibility and risk.

The Operator reserves the right to organise and execute exclusive events on the entire or a part of the area of the Sports Park, excluding usual guests.

All guests who use the services of the Sports Park can access and read this Policy at the entrance of the Sports Park or on its website (www.ospgyor.hu). Entering the Sports Park and using the services constitute the acceptance of this Policy.

Liquids necessary for the sporting activities may be taken to the designated areas and the adjacent grandstands in the Sports Park, the Multi Hall, the Tennis Hall and the Judo Hall in a closed plastic bottle, any other kind of package or equipment are strictly forbidden. It is FORBIDDEN to take glass bottles, cups to the area of the Sports Park!

Closed sports shoes must be worn in the areas designated for sport activities in the Sports Park. The footwear of the various sports may be different.

The Sports Park's operating staff, security staff, PE teachers, personal coaches, trainers and managers shall have the right to check and warn guests to the appropriate sportswear and the proper use of sports gear and equipment.

With a view to the soonest possible repair of issues occurring during use in the sanitary blocks, rooms, hallways must be notified to the Operator at the reception desk at the main entrance.

All should use the courts, sports equipment according to their intended use and physical condition, strength. The damaging party shall be liable for any damage to sports gear.

Those who have contagious diseases may not use sports services, equipment, those who suffer from heart diseases, vascular diseases, locomotor diseases may use them if they can produce a recommendation of a competent medical professional. The sportsperson shall be responsible for sporting in line with his/her health, the Operator shall exclude all responsibilities for medical issues.

The Operator shall not be liable for any injuries.

To prevent injuries, sportspersons should warm up properly before training.

It is recommended not to use the mobile phone while using the sports services.

SPECIAL RULES

Locker rooms

- The Operator shall provide a changing room separated by genders for the clients renting the facilities for sports services.
- It is recommended to wear slippers in the locker room and in the showers to avoid slipping and infections.
- The Operator shall not be liable in any way for the belongings left in the area of the Sports Park.
- The tenant/participant or their agent may take the locker room keys at the reception desk of the Sports Park, and he or she must leave them also there after the event/training.

Tennis courts

- Tennis courts can be booked for a specific period in advance, for a charge.
- The tennis court booking charges are displayed at the reception desk of the Sports Park and its website (www.ospgyor.hu).
- The Operator shall determine the conditions for booking and using the courts.

Athletic court

- The athletic warm up court is available for leisure sporting in the designated time frame.
- The court may be used wearing the right sports wear and sports shoes only!

Parking place

- Users may use the parking place in the Olimpia utca, while that in the Bercsényi liget utca is available for the Operator and the tenants only.
- Road regulations apply to the use of the parking places.

RULES APPLICABLE TO VISITORS, FANS AND QUESTS

By paying for the admission (buying a ticket, pass etc.) or entering free events or entering the Olympic Sports Park as an attendant in other cases, the visitor, fan, guest shall accept the valid Policy of the Sports Park and the rules provided by the organiser of the event as applicable to the court.

In the Olympic Sports Park, the visitor/spectator:

- agrees to identify himself or herself if the organiser calls him or her to do so,
- shall not obviously be under the influence of alcohol, narcotics or any other narcotic substance,
- shall not carry any alcoholic beverage, narcotics or any object that would pose a threat to the sports event or the physical and material security of others, or the carrying of which is prohibited by the law, or the taking of which to the sports event is prohibited by the organiser,
- shall not carry a hate sign, flag or a totalitarian symbol banned by the law,
- shall not be forbidden or excluded from the site,
- shall consent to the searching of his or her clothes and baggage,
- shall acknowledge and understand that a photo or video recording may be taken of him or her during the sports event,
- clothes and baggage of the participant may be searched by the police officer ensuring the event or the organiser, in compliance with the relevant legal provisions.
- shall acknowledge that the organisers continuously monitor adherence to the Policy during the sports event.

Present Policies may be modified or complemented by the Operator at their own discretion.
